## 3. Market Developments in Q3 2021

## **Equity Markets**

As the quarter began, the delta variant and inflation concerns jolted stocks in July, but it was a short-lived sell-off. In the face of rising inflationary pressure, global central banks started to shift to a more hawkish policy stance, pushing volatility higher especially in the month of September. In the third quarter of 2021, U.S. equities finished little changed, with the S&P 500 index gaining 0.23% while the Nasdag Composite was down 0.38%.

Globally, equity investors were showing a risk-off attitude as small caps, value stocks, and emerging-markets equities underperformed large caps, growth, and developed markets, respectively. Backed by a greater inflationary anticipation, commodities-linked stocks were among the best-performing assets. Their winning streak lasted since the beginning of 2021. A power shortage in some regions, such as Europe and China, showed that demand has increasingly outstripped supply across the energy complex. For the first time in a decade, energy stocks outperformed global equity market indexes by more than 10% in the third guarter.

Investor attention also drifted to China's systemic risks, from a regulatory crackdown on some index heavyweights to a debt struggle of the country's largest property developers. The hurt from the regulatory reset and the default episode was felt mainly by the offshore market as Hang Seng Index plummeted 14.75% in the third quarter. The SSE Composite Index, tracking the largest caps listed on the Shanghai exchange, generated a flat return over the same period.


#### **Bond Markets**

The FTSE WGBI fell 0.25% for the quarter (in USD). The 10-year Treasury yield ended at 1.52% for the third quarter of 2021, edging up from the 1.45% level at the end of second-quarter 2021.

Concerns about the economic impact of the spreading delta variant spurred a rally in bond prices in July, pushing the 10-year Treasury yield to its lowest level since February. Later on, the Federal Reserve provided a clearer timeline to start raising interest rates — one that is somewhat earlier than what the market expected. The announcement triggered rate-sensitive portions of the bond market to move lower, which resulted in yields edging up.


In the U.S. bond market, lower-quality high-yield bonds outperformed investment-grade bonds over the same period. The economy backdrop – rising prices and stabilising economic data – helped the performance of inflation-linked fixed income both in the United States and Europe. Funds that invest with an aim to peg the inflationary trends also garnered interest, as indicated by fund flows.

Despite the risk events of China's property market, U.S. high-yield credit spreads were only moderately impacted, narrowing towards year-to-date lows in September.

The Singapore average buying rates of 10-year bond yield has been on an upward trend since early August, a trend similar to the US treasury bill. Singapore's bond yield level reached 1.59% at the end of the third quarter. In contrast, the rate of the US yield finished the period at 1.52%, compared to 1.45% level at the end of June.

#### The Outlook

Several central banks voice a more hawkish policy stance, with South Korea and Norway each raising their benchmark interest rate in the third quarter. While this may be a precursor to policy tightening more broadly, it is worth remembering that both countries were among the first to hike rates in the last cycle, only to reverse course as the global economic recovery lost steam.

Closer to home, Asian equities under Morningstar coverage are generally cheaply priced, with an average price to fair value at 0.86 times, from 0.94 times last quarter. While value for Asian stocks continues to surface, volatility in the equity markets will remain prevalent towards the end of the year. For China's regulatory consolidation, it is believed that the majority of the policies were already announced for the Chinese Internet companies but that regulatory overhang may last. Morningstar foresees the aftermath of the regulatory crackdown lasting through the first quarter of 2022. The overall sentiment towards Chinese stocks will improve going forward.



In the third quarter, the overall performance of CPFIS-included funds (unit trusts and ILPs combined) turned negative. The average performance fell 1.13%, versus the second quarter's 3.31% positive return. As a comparison, the global stock and bond market ended the quarter flat. MSCI World Index returned 0.99%, while FTSE WGBI finished with a 0.25% loss. MSCI AC Asia ex Japan slid 8.43%, more than reversing the 3.65% gain from a quarter prior.

Over a longer period, funds under the CPF scheme were unable to beat the global and Asia ex Japan equity indexes. The one-year return for the CPF funds averaged 17.06%. Cumulatively, the CPF funds gained 26.46% over the past three years.

Performance differences between equity and fixed-income assets remain wide, with world equities returning more than 43.90% versus a 10.89% return in bonds.

In the past quarter, only money market funds were immune from a performance drag. The three other categories—equity, fixed income, and allocation—slightly dipped into negative terrain. Specifically, equity CPF funds turned weak, with a negative return of 1.51%. Over the same period, fixed income generated a flat average return, while allocation funds recorded a 0.89% decrease.

However, over longer reporting intervals, equity funds represented some of the best performers, with a one-year return of 23.26% and a three-year cumulative return of 31.42% on average. Allocation funds came next, returning 12.88% over the past year and 24.14% over the three-year period.




Figure 6 Average Performance of CPFIS-Included ILPs at End Q3-2021 by Asset Class (% in SGD)

By Morningstar Category, equity funds investing in the mainland China and Hong Kong markets were the worst performers. Among unit trusts, the Hong Kong equity category, comprising one fund, lost 15.32%, followed by China equity and greater China equity — both ending the period with more than a 10% loss. Funds with a primary focus on the onshore Chinese stocks, or the China equity — A-shares category, held up better, falling 7.36%. The ILP universe saw a similar performance tilt.

Conversely, between July and September, India equity was the best performer for both unit trusts and ILPs, gaining 11.72% and 11.88%, respectively. Unit trusts with an Indonesian equity strategy closely followed, with a positive return of 9.50%. The second best-performing category for ILPs was Japan large-cap equity, finishing the guarter with a 5.10% gain.

## 6. Summary of Performance

Morningstar Rating is based on funds' risk-adjusted returns within its Morningstar Category peer group. Morningstar gives more weight to downside variation when calculating Morningstar Risk-Adjusted Return (MRAR) because investors are generally risk-averse and dislike downside variation. Morningstar Rating is calculated within each Morningstar Category peer group because the relative star ratings of two funds should be affected more by manager skill than by market circumstances or events that lie beyond the fund managers' control. The Morningstar Rating is based on MRAR, using Morningstar Risk-Adjusted Return % Rank for funds in a category. Morningstar calculates ratings for the three-, five-, and 10-year periods, and then the overall Morningstar Rating is based on a weighted average of the available time-period ratings.

There are certain cases where funds are *ineligible* for Morningstar Rating. This includes funds which are:

- Categorized in any Other/ Miscellaneous category
- Restricted funds
- Virtual share classes- Also known as a convenience or currency class, virtual classes are
  investments whose performance is quoted in another currency, or allow investors to
  purchase shares in a currency other than its base currency
- Inception date/ performance start date is shorter than 36-month continuous monthly returns available
- Dormancy history led to shorter than 36-month continuous monthly returns available
- Obsolete funds
- Funds whose peer group contains less than five distinct portfolios

#### Morningstar Rating ("star rating")

To determine a fund's star rating for a given time period (three, five, or 10 years), the fund's risk-adjusted return is plotted on a bell curve: If the fund scores in the top 10% of its category, it receives 5 stars (Highest); if it falls in the next 22.5% it receives 4 stars (Above Average); a place in the middle 35% earns 3 stars (Average); those lower still, in the next 22.5%, receive 2 stars (Below Average); and the bottom 10% get only 1 star (Lowest). The Overall Morningstar Rating is a weighted average of the available three-, five-, and 10-year ratings.

## • Morningstar Return Rating

An annualized measure of a fund's excess return relative to the return of the 90-day Treasury Bill over a three-, five-, or ten-year period. This is a component of the Morningstar Risk-Adjusted Return. Morningstar Return is displayed in decimal format and is calculated only for those investments with at least three years of performance history.

#### Morningstar Risk Rating

An annualized measure of a fund's downside volatility over a three-, five-, or ten-year period. This is a component of the Morningstar Risk-Adjusted Return. Morningstar Risk is displayed in decimal format and is calculated only for those investments with at least three years of performance history. A high number indicates higher risk and low numbers indicate lower risk.

#### Morningstar Fee Level

#### 7.4 Data Definitions

#### Return

Expressed in percentage terms, Morningstar's calculation of total return is determined each month by taking the change in monthly net asset value, reinvesting all income and capital-gains distributions during that month, and dividing by the starting NAV. Reinvestments are made using the actual reinvestment NAV, and daily payoffs are reinvested monthly. Unless otherwise noted, Morningstar does not adjust total returns for sales charges (such as front-end loads, deferred loads and redemption fees), preferring to give a clearer picture of a fund's performance. The total returns do account for management, administrative, 12b-1 fees and other costs taken out of fund assets. Total returns for periods longer than one year are expressed in terms of compounded average annual returns (also known as geometric total returns), affording a more meaningful picture of fund performance than non-annualized figures.

For standard time periods (1, 3 5 and 10 years) returns are annualized as follows:

#### **Annual Report Net Expense Ratio**

The percentage of fund assets used to pay for operating expenses and management fees, including 12b-1 fees, administrative fees, and all other asset-based costs incurred by the fund, except brokerage costs. Fund expenses are reflected in the fund's NAV. Sales charges are not included in the expense ratio. The expense ratio for fund of funds only includes the wrap or sponsor fees and does not include the underlying fund fees.

#### **Standard Deviation**

A statistical measurement of dispersion about an average, which, for a mutual fund, depicts how widely the returns varied over a certain period of time. Investors use the standard deviation of historical performance to try to predict the range of returns that are most likely for a given fund. When a fund has a high standard deviation, the predicted range of performance is wide, implying greater volatility. Standard deviation is most appropriate for measuring risk if it is for a fund that is an investor's only holding. The figure can not be combined for more than one fund because the standard deviation for a portfolio of multiple funds is a function of not only the individual standard deviations, but also of the degree of correlation among the funds' returns. If

a fund's returns follow a normal distribution, then approximately 68 percent of the time they will fall within one standard deviation of the mean return for the fund, and 95 percent of the time within two standard deviations. Morningstar computes standard deviation using the trailing monthly total returns for the appropriate time period. All of the monthly standard deviations are then annualized

# **Sharpe Ratio**

A risk-adjusted measure developed by Nobel Laureate William Sharpe. It is calculated by using standard deviation and excess return to determine reward per unit of risk. The higher the Sharpe Ratio, the better the fund's historical risk-adjusted performance. The Sharpe ratio is calculated for the past 36-month period by dividing a fund's annualized excess returns by the standard deviation of a fund's annualized excess returns. Since this ratio uses standard deviation as its risk measure, it is most appropriately applied when analyzing a fund that is an investor's sole holding. The Sharpe Ratio can be used to compare two funds directly on how much risk a fund had to bear to earn excess return over the risk-free rate.

The Sharpe Ratio can be calculated one of three ways:

- 1. Standard Sharpe Ratio (SharpeRatio<sub>M</sub>)
- 2. Arithmetic Sharpe Ratio (SharpeRatio<sub>A</sub>)
- 3. Geometric Sharpe Ratio (SharpeRatio<sub>6</sub>)

#### **Information Ratio**

Information ratio is a risk-adjusted performance measure. The information ratio is a special version of the Sharpe Ratio in that the benchmark doesn't have to be the risk-free rate. The Israelson method is an adjustment of the Information Ratio to take into account the inconsistency of the IR when excess returns are negative.

#### **Max Gain**

The peak to trough incline during a specific record period of an investment or fund. It is usually quoted as the percentage between the peak to the trough.

#### Max Drawdown

The peak to trough decline during a specific record period of an investment or fund. It is usually quoted as the percentage between the peak to the trough.
